

**The “Best of TGIT Sweepstakes”
OFFICIAL RULES**

To enter and participate in this Sweepstakes, you must agree to and abide by these Official Rules.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. You must have Internet access and an active e-mail account and Twitter account to participate.

This promotion is in no way sponsored, endorsed or administered by, or associated with Twitter.

- 1. Eligibility:** The “Best of TGIT Sweepstakes” (the “**Sweepstakes**”) is open only to legal residents of the 50 United States and Washington D.C., who are at least 18 years of age (or the age of majority in the jurisdiction of their residence, whichever is older) and who have an active e-mail account, Twitter account and Internet access as of 3/15/16. Employees of American Broadcasting Companies, Inc. (“**ABC**” or “**Sponsor**”), LeadDog Marketing Group, Inc. Potential winner may be required to provide proof of eligibility prior to prize award. **Void where prohibited or restricted by law.**
- 2. Sweepstakes Entry:** The Sweepstakes begins on or about 8:00:00 p.m. PT on March 16, 2016 and ends at 11:00:00 p.m. PT on May 19, 2016. (“**Promotion Period**”). The Promotion Period consists of ten (10) separate and distinct Sweepstakes Periods as set forth in the chart below. Administrator’s computer is the official clock for this Sweepstakes. For avoidance of doubt, the Sweepstakes will be dormant in-between each Sweepstakes Period.

If you do add a photo and/or comment, all uses of the word "Tweet" in these Official Rules (as used in conjunction with entries) includes the accompanying photo/comment as well.

You may only use one (1) Twitter account to participate in the Sweepstakes. All Tweets must comply with the Twitter Terms of Service and Twitter Rules available at the Twitter Website. **Important note:** If your Twitter account is set to “protected mode,” or “private,” your Entry may not be viewable by Sponsor/Administrator, and thus, it is recommended that your Twitter account is set to “public” in order to enter.

If you opt to access Twitter via your wireless mobile device, data rates may apply for each message sent or received from your handset according to the terms and conditions of your service agreement with your wireless carrier. Other charges may apply (such as normal airtime and carrier charges as well as charges for wireless Internet access) and may appear on your mobile phone bill or be deducted from your prepaid account balance. Notice of termination/modification/suspension of Sweepstakes will be posted to each Show's Twitter account. Without limitation of any other term here, Sponsor and its agencies are not responsible for failed, partial or garbled computer transmissions, technical failures of any kind (including but not limited to electronic malfunction or damage of any network, hardware or software), any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or loss, destruction or unauthorized access to, or alteration of, entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any e-mail or electronic entry to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in this Sweepstakes.

- 3. Content Guidelines:** In addition to complying with all other requirements of these Official Rules and Twitter, each Entry must not contain any content that is profane, obscene,

disparaging or is otherwise inappropriate, objectionable, or unsuitable for the uses contemplated in these Official Rules, as determined by Sponsor in its sole discretion.

If an Entry cannot be viewed and/or accessed by Sponsor or Administrator for any reason, such Entry shall be disqualified without any fault or liability of the Released Parties, as defined below.

- 4. Random Drawings/Selection of Winners/Notification of Winners:** Potential prize winners will be selected in random drawings on or about the Monday following each Sweepstakes Period. To be eligible for any Sweepstakes Period, the entry must be received and recorded by the Administrator's computer during that Sweepstakes Period. **All non-winning entries for a given Sweepstakes Period will NOT be carried forward to subsequent Sweepstakes Periods.** For the avoidance of doubt, if an Entry is otherwise in compliance with these Official Rules (including but not limited to the Content Guidelines in Section 3 above), the content of Entry will NOT be taken into account in the winner selection process. Drawing will be conducted by LeadDog Marketing Group, Inc., an independent judging organization/Administrator whose decisions are final and binding on all matters related to the Sweepstakes.

Each potential winner will be notified via Twitter as follows: (a) if a potential winner follows at least one of the Show's accounts on Twitter (i.e., @GreysABC, @ScandalABC, @HowToGetAwayABC or @ABC_TheCatch), such potential winner will receive a direct message from such Show account; or (b) if a potential winner is NOT a follower of any of the Shows' Twitter accounts at the time of initial notification, potential winner will be sent an "at reply" to the Entry that was randomly selected by Administrator. Entrants are encouraged to regularly check their direct messages and/or at replies during and following each Sweepstakes Period. The notification message via Twitter (whether via a direct message or via an "at reply" as specified above) will request that the potential winner email the Administrator at the specified email address with specific personal information (e.g., full name, address, phone number, email address, date of birth, Twitter username).
