SUMMARY OF ELIGIBILITY REQUIREMENTS

- You may not be an employee, officer, director or agent of Derby Productions (“Derby”), The Walt Disney Company, American Broadcasting Companies, Inc. (“ABC”), or any of their affiliated or related entities; and you may not be immediate family members or members of the same household of any such people.
- You may not be a political candidate, either currently, or for up to one (1) year after the first broadcast of the last episode of the Program.
- You must be a legal resident of the United States and be living in the United States.
- Due to the nature of the grand prize, you must possess unrestricted work authorization for employment in the United States.
- You must be between the ages of 16 and 22 years old as of the date of your application.
- You will need to undergo medical and psychological testing and extensive background checks.
- You must not have been convicted of a felony, or ever had a restraining order entered against you.
- You must be able to agree to the following time commitment during which you may be separated from family and friends for approximately seven (7) weeks from approximately May 26 to July 11, 2008, which date(s) are subject to change.
- You must not be a party to a management contract, recording contract, performing contract, or any other agreement that would prevent you from freely entering into an overall exclusive talent agreement with ABC, the Walt Disney Company or any of its affiliates.

Additional eligibility requirements apply. Derby and ABC will make the decision to select or reject applicants in their sole and absolute discretion.

I grant the rights, releases and indemnities hereunder whether or not I am selected to participate in the Program. Regardless of whether I am selected to participate in the Program, I will not in any event be entitled to seek or obtain injunctive or any other equitable relief, or in any way restrain or otherwise restrict the exploitation of the Program and/or the Materials. I hereby defend, indemnify and hold harmless Releasees from and against any and all claims, expenses

(including reasonable attorneys fees) or liabilities arising out of the recording or use of my Likeness and/or the Materials and/or otherwise arising out of my Application, Producer's consideration of me as a participant, and/or participation (or non-participation) in the Program and/or the casting process (including, without limitation, any claim or liability arising out of Producer's failure or refusal to select me as a participant), Producer's use of any of the rights granted herein, or my breach of this agreement or acts, statements or omissions in connection herewith.
